  - NOTE: If you are married and you and your spouse filed separate returns or if your FAFSA marital status is different than your 2018 tax filing status, you cannot use this method. Rather, you and your spouse must each use option B or C.
- B. Submit a <u>signed</u> copy of your **2018 federal tax return**.
- C. To obtain your **2018** *IRS tax return transcript*, go to <a href="https://www.irs.gov/individuals/get-transcript">https://www.irs.gov/individuals/get-transcript</a> and request it. Click on either the "Get Transcript ONLINE" button or the "Get Transcript by MAIL" button and follow directions.
